# The categories of governance information that we process include:

- personal identifiers, contacts and characteristics (such as name, date of birth, contact details and postcode)
- governance details (such as role, start and end dates and governor ID)

## Why we collect and use governance information

The personal data collected is essential, in order for the school to fulfil their official functions and meet legal requirements.

We collect and use governorance information, for the following purposes:

a) to meet the statutory duties placed upon us

Under the General Data Protection Regulation (GDPR), the legal bases we rely on for processing personal information for general purposes are:

• for the purpose **a**) named above in accordance with the legal basis of **Legal Obligation** 

Under <u>section 538 of the Education Act 1996</u> we have a legal duty to provide the governance information as detailed above.

In addition, concerning any special category data:

- processing is necessary for the purposes of carrying out the obligations and exercising specific rights of the controller or of the data subject in the field of employment and social security and social protection law in so far as it is authorised by Union or Member State law or a collective agreement pursuant to Member State law providing for appropriate safeguards for the fundamental rights and the interests of the data subject;
- processing is necessary to protect the vital interests of the data subject or of another natural person where the data subject is physically or legally incapable of giving consent;
- processing is carried out in the course of its legitimate activities with appropriate safeguards by a foundation, association or any other not-for-profit body with a political, philosophical, religious or trade union aim and on condition that the processing relates solely to the members or to former members of the body or to persons who have regular contact with it in connection with its purposes and that the personal data are not disclosed outside that body without the consent of the data subjects;

## **Collecting governance information**

We collect personal information via:

- application forms
- Secure file transfer or paperwork
- Information from governors

Governance data is essential for the school's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it may be requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

## **Storing governance information**

## Who we share governance information with

We routinely share this information with:

- our local authority (where applicable)
- the Department for Education (DfE)

## Why we share governance information

We do not share information about individuals in governance roles with anyone without consent unless the law and our policies allow us to do so.

The law allows us to share pupils' personal data with certain third parties, including:

- schools
- local authorities
- researchers
- organisations who make products connected with promoting the education or wellbeing of children in England
- other government departments and agencies

Anyone who wants to use our data must comply with:

- strict confidentiality and security rules
- the Data Protection Act 2018
- the General Data Protection Regulations (GDPR)

When we collect data about an individual, it typically contains things like their:

- name
- address
- school or college name

• identifiers such as the unique learner number

Under data protection law, this is called personal data. Personal data includes data that, when combined with other reasonably available data, identifies an individual.

When sharing personal data there are 2 important issues that individuals are worried about, the:

- risk of identification what's the potential for identifying individuals within the data
- <u>sensitivity of the data</u> what's the impact on an individual if they're identified

We now classify all of data leaving us against 2 criteria:

- how sensitive the data item is
- the level of risk that an individual could be identified

This makes it easier for us to be transparent about:

- what kind of data we share with third parties
- our decision making

#### Local authority

We are required to share information about our governors with our local authority (LA).

#### **Department for Education**

The Department for Education (DfE) collects personal data from educational settings and local authorities. We are required to share information about individuals in governance roles with the Department for Education (DfE):

We are required to share information about our governors with the Department for Education (DfE) under section 538 of the Education Act 1996

All data is entered manually on the GIAS system and held by DfE under a combination of software and hardware controls which meet the current <u>government security policy framework</u>.

## Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. To make a request for your personal information, contact: admin@freshstepsindependentschool.org.uk

You also have the right to:

- to ask us for access to information about you that we hold
- to have your personal data rectified, if it is inaccurate or incomplete
- to request the deletion or removal of personal data where there is no compelling reason for its continued processing
- to restrict our processing of your personal data (i.e. permitting its storage but no further processing)

- to object to direct marketing (including profiling) and processing for the purposes of scientific/historical research and statistics
- not to be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect on you

## How Government uses your data

The governance data that we lawfully share with the DfE via GIAS:

- will increase the transparency of governance arrangements
- will enable maintained schools and academy trusts and the department to identify more quickly and accurately individuals who are involved in governance and who govern in more than one context
- allows the department to be able to uniquely identify an individual and in a small number of cases conduct checks to confirm their suitability for this important and influential role

## **Data collection requirements**

**Note:** Some of these personal data items are not publically available and are encrypted within the GIAS system. Access is restricted to a small number of DfE staff who need to see it in order to fulfil their official duties. The information is for internal purposes only and not shared beyond the department, unless the law allows it.

#### How to find out what personal information DfE hold about you

Under the terms of the Data Protection Act 2018, you're entitled to ask the Department:

- if they are processing your personal data
- for a description of the data they hold about you
- the reasons they're holding it and any recipient it may be disclosed to
- for a copy of your personal data and any details of its source
